### In Memoriam



Brother **Thomas Ronald "T. Ron" Jasinski-Herbert**, born November 1, 1938; passed away August 17, 2015 Beloved son of the late Leona "Lee" Jasinski Herbert and the late Thomas H. Herbert, cherished nephew and godson of Loretta Sobocinski "Lori Sobin" and nephew of Michael K. (the late Rosemary) Jasinski, devoted cousin of Karen Mackay, Jeanine (Richard) Galati, Patricia (Ken) Brendecke, the late Suzanne Luckew, and many others across the country. He also leaves behind a myriad of lifelong friends in Chicago and around the world. Brother T. Ron earned a Bachelor of Arts degree from DePaul University, and LLB and JD degrees also from DePaul University and remained an active alumnus. Brother T. Ron celebrated life and embraced every effort to improve his community.

Among his many accomplishments: Brother T. Ron was President of Ameripol, Corporation, Inc.; President of Polonia Media Network; Publisher and Editor-in-Chief of "Polonia Today"; President of the Polish Arts Club of Chicago; past President and current Advocate of the Chicago Society PNA; founding President and current member of the Board of the Chicago Society Foundation; Director of the International Polka Association; Director of the Polish American Congress; former Director of Public Relations of the Polish National Alliance; founder, along with his mother Lee Herbert, of the Heritage Club of Polish Americans; past President of the Advocates Society; past Director of the Polish National Alliance; past Director of the Polish American Congress, Illinois Division, practiced law in his office on Milwaukee Avenue; founder and president of ETC (Ethnic Television Channel), the first and only English-language television cable channel; candidate for Clerk of the City of Chicago; active member of various Democratic Party organizations; led tours to Poland, Germany, and Russia, since he was fluent in those languages; producer of several documentaries on Polish topics; television, print and on-line journalist; social and political commentator. Brother T. Ron dedicated himself to anything he became involved with, often readily taking a leadership role, captivating everyone with his infectious laugh. He was a friend and mentor to many generations, a strong defender of all things Polish, and great friend of Polonia. Brother T. Ron was extremely active but the Chicago Society is where he invested his love and time.

A celebration of T. Ron's life was held on August 29, 2015, at Skaja Terrace Funeral Home, organized and conducted by Brother **Ted Wiecek** and attended by many brother members of the Chicago Society. The Celebration began with readings and prayers for the deceased by Rev. Lawrence Springer of St. Zachary Church in Des Plaines. Brother **Frank Spula** then shared his memories of T. Ron, both with the PNA and personal, followed by Brother **Richard Ciesla**, who shared his memories of T. Ron during his over 40 years involvement with the Society. Others who shared their memories were Alicia Dutka, president of the Polish Arts Club of Chicago, Mark Dobrzycki, who worked with T. Ron at ETC, and Rick Rzeszutko, president of the International Polka Association. Jaroslaw Golembiowski and Aleksandra Podowska provided some musical enhancements to the event. The celebration then moved to the Lone Tree Manor, where his family and friends continued to share their fond memories of T. Ron to the strains of his favorite polka tunes. T. Ron certainly was smiling on all who celebrated his life.

Big wheels keep on turning as Brother President **Ted Makarewicz** joined in on another almost annual rite of summer motorcycle trip planned by friend Brother **Carlton Marcyan** to the annual motorcycle rally in Sturgis SD. This year's occurred the last week of July and celebrated the 75th Anniversary of the "Black Hills Rally." Attendance was at an all-time high with more than a million bikers. Carlton and his lawyer-biker friend, Joseph Rominski, riding all the way their Harley Davidson touring bikes, stayed in Deadwood SD for 4 days and then left for other parts west including Coeur D'Alene, Idaho; Cascade Mountains; Seattle WA; travelling south on the Pacific Coast down US Highway 101 into southern Oregon. Then riding east through the Nevada desert without a gas station for 250 miles, the riders saw a meteorite on fire and vaporize at about 5,000 feet in the sky. They continued through the Bonneville Salt Flats and Salt Lake City, Wyoming, where they rode parallel to a US Air Force Convoy of armored vehicles with mounted machine guns accompanied by armed helicopter all escorting nuclear missiles from Cheyenne to ICBM sights further east, Nebraska, Iowa and then home for a total of 6,000 miles round trip returning safe and sound.

Brother **Ted Makarewicz** found some time off in August to do a 9 day motorcycle ride to Iowa, Nebraska, Wyoming, Colorado, New Mexico, Oklahoma, Kansas and Missouri covering approximately 3,200 miles. He even drove his bike to the top of Pike's Peak, elevation 14,110 feet. Later in the month, he also rode to Springfield, Illinois, with Governor Bruce Rauner escorted by the Illinois State Police and a

group of veterans on the first annual Governor's Motorcycle Run which concluded with a BBQ dinner at the governor's mansion.

## 2016 ELECTION OF OFFICERS AND DIRECTORS

The Nominating Committee for the Chicago Society of the PNA's election of 2016 officers and directors invites anyone interested in running for a position on the board, either as an officer or director-at-large, please contact the Chairman or another member of the nominating committee to find out the procedure and qualifications. You must contact them as soon as possible because the slate will be announced at the October meeting. The chairman and committee will be announced at the September General Dinner Meeting.

### RULES FOR VOTING AND RUNNING FOR OFFICE IF NOT SLATED

The Nominating Committee shall select at least one candidate for each elective position who shall be required to sign an acceptance of nomination. At the October meeting, the chairman of the Nominating Committee will announce the slate of candidates that has been selected. Any member may run against a slated candidate for a particular office. The rules and procedures for doing such are stated in the Constitution, Article VII: Election of Officers and Directors. At the regular meeting in October the Nominating Committee shall accept for nomination such additional lists of candidates for the respective offices as may be submitted by the petitions of ten or more members, provided however that the signed acceptance of each candidate is attached to each such petition. The adjournment of the meeting shall close the nominations in the absence of a motion for that purpose. Immediately thereafter, the nominating committee shall submit a list containing all of the names of the candidates to the Recording Secretary who shall cause the publicizing of such list to all members in good standing at least ten days prior to the date of the November election meeting. The President shall appoint five Judges of Election, if necessary, who shall prepare a ballot, have charge of the polls of election, canvass the votes and certify the results to the Recording Secretary. Only members in good standing shall be eligible to be elected, to sign petitions or to vote. No member admitted to membership in the Society within five days of election shall be eligible to vote at the election.
